<u>CALL THE REGULAR MEETING TO ORDER:</u> Mayor called the regular meeting to order at 6:00 P.M.

Lillian Miller from the LaPaz County Career Center introduced Joshua Vale to mayor and council as she explained how having the youth of Parker be part of the Coyote summer employment is beneficial for both the youth and for the employers; Joshua added his experience with the program has lead him into the world of LaPaz Hospital where he has chosen a medical career as a Ex-ray Tech.

Mary Hamilton Executive Director from the Chamber provided council with a power point presentation with highlights how the last fiscal went and what is expected for the next. Various education classes have been offered and attended by many, she herself plans to attend a chamber management training session. Big thing on the horizon is the June Tube Float everyone is invited to participate.

Josh Savino was introduced to the council as the new Tourism Director at the Chamber; Josh too provided the group with a computer look at how email, Face book, tweeter, etc marketing is affected by and used in the tourism department.

Skip Becker from LaPaz Economic Development told the council things are changing for

the better with industry here in Parker; though he cannot tell who or what the new business is coming to the area that will allow 30-40 people new jobs. He asked everyone to support the leaders we have and if asked how's things in Parker reply;"Things in Parker are great, and we are Parker Strong"!

Roberta Hoffman the chairman of LaPaz Economic Dev. added the town is strong and there are exciting things to come and that is directly due to this great council and with their decisions.

Magistrate Judge Putz-Artrup explained this would be the second visit of ordinance 01-2014 amending the town code to allow for a pro-tem should there be a need. Once approved the ordinance would be recorded, and then it becomes law and the code would reflect the change. No comments

Town Manager Wedemeyer explained the town has annually supported the summer youth programs; the Coyote Program is just one of the many staff recommends that council fund for 3 youths at \$2,000 each annually again this season.

Public Works Director Edwards explained P & R on April 14th were presented various summer programs, it was the committee's recommendation this program be council's selection for funding for the 2014 summer recreation program for the allotted and budgeted \$5,600.00.

Public Works Director Edwards explained last meeting council selected a project for the CDBG funding, housekeeping requires council authorizes the resolution 07-2014 for the grants submittal.

6. Approve/Deny funding the annual Pop Harvey Aquatic Association Learn to Swim and Swim Program

Public Works Director Edwards explained the PHAA has annually provided a swim program to teach the Parker youth how to be safe and learn how to swim; this is a budgeted item. CM Collett added he someday would like to see the youth have a larger swimming pool to swim in. Mayor added the comment that the association deserves big kudus for teaching so many of our youth how to swim.

Public Works Director Edwards explained annually CRIT allows the use of the Kofa Motel swimming pool for swim lesions; the previous item was to allow tots to swim; this second camp is for the older youth to also learn too

4. Approve/Deny appointing Jim Merritt to a second four-year term of the Town of Parker Streets and Traffic Committee ending in June 2018.

Public Works Director Edwards explained this is housekeeping to allow S & T committee member Merritt to sit for an additional 4-year term; CM Savino commented he would like to see some of the younger adults to sit on the town boards.

5. Approve/Deny to extend the employment agreement of Town Magistrate Jim Putz-Artrup for an additional two-year term through November 6, 2016.

Town Manager Wedemeyer explained that it is time to renew Judge JP Agreement for an additional two year period. CM Collett commented he thought having JP as the judge has brought the department to a higher level in professionalism; CM Yackley inquired who evaluates the Judge. Judge JP replied the State Supreme Court does and added his department has also passed its annual financial audit.

10 Approve/Deny accept a recommendation from Planning and Zoning Commission to change the zoning from R2 Residential Medium High Density to R3 High Density Residential Zoning that property located at 1412 14th Street by adopting Ordinance 02-2012 (first reading title only)

Public Works Director Edwards explained all the steps that have been taken to change the zoning on this property, which currently is non-conforming and really not legal with the three separate residences on the one lot. He explained residential 2, and residential 3zoning, what is allowable and what is not. VM Hooper asked about OT and was told the lot is not zoned for that. CM Yackley stated he has a big problem with spot zoning and with R3 zoning. There is no other R3 zoning within the town limits though at Parker South there is, was discussed. CM Collett asked about the public concerns were there any; he was told yes; three families came to the neighbor meeting, to the Planning and Zoning hearings, and have voiced big concerns. Libby Shontz one of the concerned neighbors was asked to tell council about her concerns. The concern is not for today but for the tomorrows, after this council is gone what happens to the property then; sometime change is not for the better; would this change open the door to other problems in the neighborhood, traffic speeding, drugs, concerns have been raised. Mayor stated he has spoken with the applicant who told him he could remove the existing mobile home and build a nice 2 bedroom house; or iust leave the mobile unit alone, clean it up and just rent it out as is with the other two units on the lot if the zoning isn't changed. CM Hartless commented it's like the applicant is saying it's my way or else. VM asked about grandfather rights and mobile homes; this too was discussed, but again the lot it is not zoned for that. CM Savino stated he would like to see the applicant provide a master and site plan of what he plans to do. The percentage of lot use was also discussed; resident Walter Shontz commented the neighbors are just very concerned what type of headaches changing this lots zoning might cause years from now.

3rd Quarter Financial Update for Fiscal Year 2013/2014 Lori Wedemeyer, Town Manager

Town Manager Wedemeyer explained the 3rd quarter fiscal year 2013 and 2014 revenues verses expenditures for the council. Funding would be better had there not been the recent lawsuits the town had recently paid the attorney fees for; however, in one of the suits the town would be recouping some of those funds. She explained to council member Collett the stasis of bed tax earnings, where they come from and where they are earmarked for. Information on the HURF funds was positive, we are getting more money but we could be spending more if Tim could get contractors to bid the road projects. VM asked should we ask to make the projects bigger, this is unknown, but staff would keep working on it. Budget sessions would be scheduled for this month council was informed.
