Public Works Director Edwards explained the gazebo at Pop Harvey Park suffered major damages in July of this year when the strong winds caused a tree to fall. Poston Rotary made a presentation to the parks and recreation committee for a replacement to the gazebo and improvements to the whole parks landscaping; cost for said improvements would be covered through the settlement check from the insurance carrier.mr Edwards added municipalities have the ability of using state purchasing agreements saving the cities and towns general funds. Neither Mohave Educational nor the state has a contract that is applicable for this application; however, Houston-Galveston area does. Staff recommends council approve and adopt resolution 22-2013 to execute and enter into a Interlocal contract for the purchase of the materials and equipment used by the town for this application.
